# PUBLIC NOTICE Meeting Agenda for Friday, September 1, 2017

Hurricane/Tropical Storm Harvey made landfall on the weekend of August 25, 2017, the hurricane/storm directly impacted the community served by TCCC and its employees and directors, the Governor of Texas declared a state of disaster for approximately 50 counties including Harris County which has the student population which TCCC serves, significant flooding has impacted TCCC community area causing significant damage to area property and school facilities.

Current weather conditions and the flooding impact of hurricane/storm created a catastrophe which physically interfered with the ability of the TCCC Board to conduct the meeting originally noticed for 5:30 PM on Tuesday, August 29, 2017 and created an emergency and urgent public necessity requiring immediate Board action because of the imminent threat to public health and safety of the flooding or the reasonably unforeseeable situation of the extent and severity of the flooding.

For the foregoing reasons, the TCCC Board President, determined that TCCC was prevented from convening its August 29, 2017 Board meeting, that the convening at one location of a quorum of the TCCC Board is difficult or impossible, and as a result, the Board will convene a meeting at 2:00 PM on Friday, September 1, 2017, at the TCCC's central administration offices at 2950 Broadway, Houston, Texas 77017, and that such meeting will be held by telephone conference call, subject to the Board's agreement with the foregoing reasons and the holding of the meeting by telephone conference call — to be done as the first order of business. Each part of the telephone conference call meeting that is required to be open to the public shall be audible to the public at the location specified in this notice and shall be recorded. The recording shall be made available to the public. This location shall provide two-way communication during the entire telephone conference call meeting and the identification of each party to the telephone conference shall be clearly stated prior to speaking.
